## **Participation in Power Supply Business for the Power Producer and Supplier**

Ichihara Power Co., Ltd. ("Ichihara Power", President: Kanji Shimada), a joint venture between Mitsui Engineering & Shipbuilding Co., Ltd. ("MES", President: Takao Motoyama) and Electric Power Development Co., Ltd. ("J-POWER", President: Yoshihiko Nakagaki), signed a power supply agreement on March 1 with Nippon Steel Corporation, a Power Producer and Supplier (PPS). Ichihara Power has thus entered the power supply business for PPS's.

Ichihara Power was established in December 2002 as a joint venture between MES and J-POWER for the purpose of constructing and operating a 100MW capacity gas-turbine combined-cycle thermal power plant on the MES Chiba factory compound (Ichihara, Chiba Prefecture). Ichihara Power will commence construction work on the power plant next week on March 17. The plant is scheduled to go into commercial operation in October 2004.

MES has a proud record of gas turbine, steam turbine and diesel power plant construction and has extensive experience in power plant operation both in Japan and abroad. Its involvement in Japan's first PPS power supply project is therefore an important step in its commitment towards the aggressive expansion of its power plant operation and maintenance activities as an integral part of its ongoing Life-cycle Solution Service business.

J-POWER has acquired solid experience in power wholesale to general power operators over many years and is determined to launch out into new business areas with the confidence of being able to capitalize on this well-established know-how. Its participation in the present PPS power supply project marks a first step in this direction.
