Progress Report on Suspension of Operation of No. 1 Unit at Tachibanawan Thermal Power Plant

Electric Power Development Co., Ltd. announces the current status and future outlook regarding the "Suspension of Operation of No. 1 Unit at Tachibanawan Thermal Power Plant" announced on March 14, 2024.

1. Current status

Regarding the suspension of No.1 Unit of Tachibanawan Thermal Power Plant since February 15, 2024, a crack was observed in a part of the High temperature reheat steam pipe. The cause of the crack is still under investigation.

2. Outlook

The restoration plan as of May 9, 2024, is to replace the cracked pipe. The power plant is expected to resume operation at the end of February 2025, which has not been changed from the previously announced date.

The impact on consolidated operating income for the current fiscal year is expected to be 18 billion yen due to restoration costs and the decrease in sales.
